According to the report submitted to the University by the Local Inquiry Committee after visiting your college in pursuance of the renewal / natural expansion proposal, the feedback given by the Scrutiny Committee and the regular Principal, Librarian, Director of Physical Education (as required) and appointments made through the University Selection Committee for teaching posts required in relevant courses, appointments to non-teaching posts and other necessary physical facilities available etc. of your college. Having observed the University Authority Board has approved the renewal / natural extension of affiliation as mentioned in the above table.
2. If you have not done the NAAC/NBA evaluation/re-evaluation as required by your college/institution, it will be mandatory to do it immediately. If this is not fulfilled, proposals for further renewal / natural expansion will not be accepted.
 3. In case of obtaining less than 65% marks in Annexure 'A', 'B' or 'C' for the next three consecutive years from the academic year 2019-20, a proposal for cancellation of affiliation under Section 120 of the Maharashtra Public Universities Act, 2016 will be submitted to the University Authority Board, it should be taken seriously.

Since the approval of renewal / natural extension of affiliation is subject to the fulfillment of the conditions imposed by the local inquiry committee and the scrutiny committee, the college should fulfill all the said conditions and submit the compliance report along with the true copies of the relevant documents to the university within two months from the date of this letter. Please note that approval for renewal of said affiliation will be maintained only after fulfillment of those conditions and approval of the same by the Academic Council.

Also, due care should be taken to submit the proposal for approval of further affiliation to the University within the prescribed fee keeping in mind the period of above approval.
